## CPTED

Crime Prevention Through Environmental Design (CPTED) is widely used overseas but its potential has not been reached in Australia. CPTED recognises that the physical environment contributes to opportunity for crime and people's perception of safety. CPTED has proved effective in reducing opportunity for crime and the fear of crime by creating environments that increase people's perception of safety whilst simultaneously increasing the perception of risk to intruders/offenders.

CPTED is a valuable alternative security strategy for applications where aesthetics are important, or to support existing electronic and physical security measures. Incorporating CPTED into the design of an office, building or community improves inherent safety/security and reduces the necessity for expensive, ongoing security measures and procedures. CPTED can be very effective in spaces such as schools, shopping centres, offices, sporting facilities, transit facilities and town planning.
